About the conference

Young people who experiment with alcohol and other drugs, whether legally or illegally obtained, may unwittingly compromise their safety and wellbeing or the safety and wellbeing of others.

Evidence suggests that young people who use alcohol and other drugs are more likely to participate in other high-risk activities, and to be involved in violent and traumatic incidents such as assaults. Inexperience and peer influence undoubtedly contribute to these harms. In addition, use of alcohol and other drugs can increase young people's risk of committing crimes and lead to early involvement in the criminal justice system.

Questions that need to be explored in this context include:

- What is the nature and extent of young people's involvement in alcohol, other drugs and violence?
- What interventions are likely to reduce risks resulting from, and increase resilience to, these potentially harmful activities?
- What can we learn about the experiences of young people and practitioners that can be applied in practice?

The Australian Institute of Criminology and the Victorian Safe Communities Network will explore these and other questions and ideas over two days at this important conference to identify effective interventions and approaches.

The Victorian Safe Communities Network is a professional association of community safety practitioners, researchers and policymakers.

The Australian Institute of Criminology is Australia's national research and knowledge centre on crime and justice.

Call for abstracts

Abstracts are invited for papers on the risk factors for young people's involvement in alcohol, drugs and violence, and programs and initiatives which aim to reduce risk of, and increase resilience to, these harms for young people, particularly those at risk of deeper involvement in the criminal justice system, and young offenders.

Papers could include the following approaches:

- Understanding the nature and extent of young people's involvement in violence
- Identifying effective programs and initiatives to reduce young people's risk and increase their resilience, including:
 - Early intervention programs

Preparing an abstract

The abstract should outline the subject of the presentation in no more than 250 words. Additionally, it should include a concise title and the full names and contact details of the authors. The presenting author should be clearly identified. A brief personal biography (approximately 100 words) from the presenting author must also be included. Please do not include any acknowledgements, figures or references in the abstract. Please provide details if you have presented this paper previously (ie. conference, conference location and date).

Please indicate on your abstract submission form if it should be considered for a 30 minute presentation (20 minutes presentation, 10 minutes questions) or a one-hour workshop or panel discussion.
